महोदय,

वरील संदर्भिय पत्राच्या अनुषंगाने आपणास कळविण्यात येते की, आपण पाठविलेली आपल्या संस्थेच्या श्री.साईबाबा भक्त मंडळ संचलित, कला वरिष्ठ महाविलय, महासावद, ता.शहादा जि.नंदुरबार.या महाविद्यालयाची प्राचार्य व ग्रंथपाल पदाची जाहिरात तपासली व ती मान्य करून सोबत पाठवित आहोत. सदर जाहिरात विद्यापीठामार्फत राज्यस्तरीय वृत्तपत्रात दिल्यावरच यु.जी.सी. व महाराष्ट्र शासनाच्या नियमानुसार आपण स्थानिक (जळगांव, धुळे व नंदुरबार जिल्ह्यात) दोन वेगवगळ्या वर्तमानपत्रात व एक राष्ट्रीय पातळीवर प्रसिद्ध करावी.

वरील परिच्छेद क्र.१ मध्ये नमूद केल्याप्रमाणे जाहिरात प्रसिद्ध करण्यासाठी कार्यवाही करून संबंधीत महाविद्यालयाची जाहिरात महाविद्यालयामार्फत राष्ट्रीय व राज्यस्तरीय वृत्तपत्रात प्रसिद्ध केलेल्या जाहिरातीची कात्रणे, तसेच स्थानिक वृत्तपत्रात प्रसिद्ध केलेल्या जाहिरातीची कात्रणे, अशी सर्व कात्रणे साक्षांकित करून विद्यापीठास त्वरीत सादर करावीत त्याशिवाय निवड समितीचे नावे दिली जाणार नाहीत. जाहिरातीतील ज्या पंदासाठी पात्र उमेदवाराचे अर्ज प्राप्त झाले असतील, त्याच पदासाठी निवड समितीची नावे मागणी करावीत, म्हणजे मुलाखती घेणेकरीता निवड समितीच्या सदस्यांची नावे कळविण्याबाबतची कार्यवाही करणे मुलभ होईल. तसेच निवड प्रक्रिया पूर्ण करून निवड समितीचा अहवाल त्यानुसार नियूक्त केलेल्या प्राचार्य व ग्रंथपाल पदावरील नेमणूक मान्यतेचा प्रस्तावही भरून आवश्यक त्या कागदपत्रांसह स्वतंत्र फाईलमध्ये विद्यापीठास सादर करणे आवश्यक आहे.

**MINIMUM QUALIFICATION FOR APPOINTMENT TO THE POST OF PRINCIPAL IN COLLEGES, AS PER UGC REGULATIONS, 2018 and G. R. dated 8 March, 2019.**

**A. Eligibility:**

- Ph.D. degree;
- Professor/ Associate Professor with a total service/ experience of at least fifteen years of teaching/research in Universities, Colleges and other institutions of higher education;
- A minimum of 10 research publications in peer-reviewed or UGC-listed journals; and
- A minimum of 110 Research Score as per Appendix II, Table 2

**B. Tenure:**

A College Principal shall be appointed for a period of five years, extendable for another term of five years on the basis of performance assessment by a Committee appointed by the University, constituted as per government resolution dated, 8th March, 2019.

**General Conditions:-**

- Service conditions and other rules will be as prescribed by the UGC, State Govt. and KBC North Maharashtra University.
- The original certificates must be produced at the time of interview.
- Candidates already employed must submit their applications through proper channel.

**LIBRARIAN**

**MINIMUM QUALIFICATION FOR APPOINTMENT TO THE POST OF LIBRARIAN IN COLLEGES, AS PER UGC REGULATIONS, 2018 and G. R. dated 8 March, 2019.**

- A Master's degree in Library Science, Information Science or Documentation Science or an equivalent professional degree, with at least 55% marks (or an equivalent grade in a point scale, wherever the grading system is followed).
- A consistently good academic record, with knowledge of computerization of a library.
- Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR, or a similar test accredited by the UGC, like SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M. Phil. / Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be. *Provided* that, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances / Bye-laws / Regulations of the Institutions awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/ SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:

- a) The Ph.D. degree of the candidate has been awarded in regular mode only;
- b) The Ph.D. thesis has been evaluated by at least two examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal; and
- e) The candidate has presented at least two papers, based on his/her Ph.D. work in conferences /seminars, sponsored/funded/supported by the UGC/CSIR/ICSSR or any similar agency.

**Note:**

- 1) The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic affairs) of the University concerned.
- 2) NET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SET is not conducted. However, Ph.D. degree shall remain the minimum eligibility for the appointment in such disciplines. • A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders who have obtained their Master's Degree prior to 19 September, 1991.
- A relevant grade which is regarded as equivalent of 55%, wherever the grading system is followed by a recognized university, at the Master's level shall also be considered valid.
- A relaxation of 5% shall be allowed at the Bachelor's as well as at the Master's level for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently-abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; (e) Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.



2. The original certificates must be produced at the time of interview.
3. Candidates already employed must submit their applications through proper channel.
4. As per Govt. Resolution No. STC-1099/PK-14/C-10, dated 16 August, 2000 & STC/14200/PK-43/C-10, dated 27th January, 2003 candidates belonging to ST Category is mandatory to submit cast validity certificate at the time of interview.
5. The reserved category candidates should submit their Caste Validity Certificates as per the Government Resolution.
6. As per the Government Resolution NO. BCC-2016/PK 228A/16/16 B, dated 29th May, 2017, A/B/C/D points in VJ/NT Category are interchangeable.
7. The Reserved category candidates (except SC and ST) should submit their Non-creamy Layer Certificate at the time of interview.
8. For reserved category post, candidates belonging to the concerned reserved category only can apply.
9. 30% Reservation for women shall be observed as per Government norms.
10. 4% reservation for persons with disabilities as per G.R. dated 29.05.2019 shall be observed
